I understand that should they be found to have received more than five (5) Class 2B Passenger, five (5) Class 2B Commercial – Class 8 rebates, and three (3) Ice Resurfacer rebates from the Program in a calendar year, the dealership(s) who provided the rebate(s) OR the Program Administrators may seek to recover the amount of the rebate provided.

If it is determined that they have not done so the Program has the right to seek reimbursement for a prorated amount of the rebate based on the amount of time the vehicle was kept for.

## Consumer Consent

This information is being collected by the Program Administrator and will be shared with the Department of Energy for the purpose for the purpose of:

1. administering the Program, which includes but is not limited to determining the eligibility for a rebate under the Program and evaluating the Program including informing future program policy related to medium and heavy-duty zero emission vehicles; and
2. validating eligible medium and heavy-duty zero emission vehicle purchases, which involves reviewing the vehicle identification number and postal code of the purchaser / lessee.

The personal information collected will be shared only with those employees of the Program Administrator and the Department of Energy as is reasonably required for the administration and evaluation of the Program. Under the provisions of the *Freedom of Information and Protection of Privacy Act*, individuals have the right of access to, correction of and protection of their personal information.
